WHY DEWORM DAILY?

Certain risk factors may call for daily deworming to help maintain health and peak performance:

- ☐ Boarding and training barns
- ☐ Movement on/off farm for training or competitions
- ☐ High-risk age groups such as foals, weanlings and geriatric horses
- ☐ High stocking densities (over two horses per acre)
- ☐ Non-rotated pastures
- ☐ Continuous parasite exposure
- ☐ Horses with insulin resistance or Cushing's Disease
- ☐ Confirmed fecal egg count of 200 to 500 eggs per gram

If your horse meets one or more of these risk factors for parasite infection, talk with your veterinarian about an Individualized Deworming (ID) program involving STRONGID C or C 2X.

HOW DO STRONGID C AND C 2X STACK UP?

SAFE

- Active ingredient (pyrantel tartrate) is potent, yet safe.
- For use in mares at any stage of pregnancy and in stallions.
- Foals may be administered STRONGID C or C 2X as soon as consistent intake of grain mix is occurring. This is generally between 2 to 3 months of age.

EFFECTIVE

- Kills *Strongylus vulgaris* larvae before they can damage vital organs or grow into adulthood and produce eggs that contaminate pastures.
- Effectively controls adult large strongyles, and the adult and larval stages of small strongyles, pinworms and ascarids.
- STRONGID C (pyrantel tartrate) provided a high level of control for adult and fourth-stage ascarids (roundworms) with efficacies of up to 100 %, confirmed by two separate field studies.¹

EASY

- Alfalfa and molasses-based pellets help ensure eager consumption and can be top dressed or mixed into any feedstuff.
- Original STRONGID C requires 4 ounces daily per 1,000-pound horse.
- Concentrated STRONGID C 2X requires 2 ounces daily per 1,000-pound horse.

GETTING STARTED IS EASY

First, work with your veterinarian to determine your horse's ID program needs.

Next, administer a broad-spectrum purge dewormer such as QUEST® PLUS (moxidectin/praziquantel) Gel to treat your horse for existing parasites such as encysted small strongyles and tapeworms, and then begin daily treatment with STRONGID C or C 2X.

Finally, work with your veterinarian to determine the ideal duration for daily treatment and frequency of

purge deworming necessary based upon your horse's parasite risk factors and unique ID program.
